Seeing Ezra Mougls for the first time, your mind might race to visions of him having been abused, having been in a life-threatening fire or something of the like, but you would be wrong.

Regarding people's stares, Riverview resident Pierce Simeone says, "That is the thing that gets to you the most," revealing that his two-year-old grandson actually suffers from the debilitating disease known as

FORMER BODY SHOP OWNER USES TRADE SECRETS TO REMOVE DENTS

If your vehicle has dings, dents or paint damage, local Lithia resident Troy Alexander, owner of Dent Houdini, LLC, can make it disappear like magic.

In the cosmetic body business for 27 years, Alexander offers mobile body and paint repairs and is certified in paintless dent removal as well. "Most minor damage doesn't require body shop work," Alexander said. "Within a matter of minutes, you often don't even know it was there."

Alexander, who owned a body shop in Atlanta years ago, later trained in the paintless dent removal, where dents are massaged out of the metal by working from behind the panel using a variety of specially designed tools. This maintains the factory finish, as this process eliminates the need for sanding, filler and repainting. Heavier

damage can also be fixed by appointment at Dent Houdini's farm location in Lithia.

Though Alexander worked in the corporate automotive world for years as a franchise owner, he's now a one-man show and proud of it. He prefers to maintain customer satisfaction by keeping his expertise local. He said, "My family and I have

lived in Lithia for the last 10 years and have our roots here now. Most of my business comes from referrals by happy customers, friends or neighbors, and that's fine with me."

He went on to say, "Dent Houdini's goal is to come to you and fix your car on the spot without hurting your wallet. The worst thing people do is attempt to hammer out their own dents, which ruins the metal's integrity. If you have damage, leave it to a professional to repair, otherwise it might be more expensive to remedy down the line."
